**CIRCULAR**

In continuation to previous circulars issued from this office vide F.No 12(37) NCERT/Acad/SCERT/2021/7612-24, dated 29-10-2021, F.No. 12(37) NCERT /Acad/SCERT/2021/7792-7802, dated 2-11-2021 and F.No. 12 (37)NCERT/Acad./SCERT/2021/7971-81, Dt 8<sup>th</sup> November 2021 regarding NAS,2021.

It is hereby directed to all DDEs ( District/ Zone), DDE ( PSB & ASB) to ensure strict compliance with obligations outlined by CBSE under the aegis of Ministry of Education , Govt of India for successful conduction of National Achievement Survey (NAS) on 12<sup>th</sup> November 2021 as below:

1. **Ensure that all categories of sampled schools which includes State Govt. schools, Govt. Aided schools, Private Unaided recognized schools and Central Government schools are functioning for the sampled grade ( 3, 5, 8 & 10<sup>th</sup>) on 12<sup>th</sup> November 2021 in the morning shift, even if it is the Evening shift School.**
2. **It is further mentioned that in each educational district many evening schools have been selected as sample school for survey. Hence concerned DDEs must ensure that evening schools are open as per the time schedule of survey. DDEs must also ensure that all categories of sample schools including private schools in the sample list are running with full attendance in the selected Grades on 12<sup>th</sup> November 2021.**
3. Time schedule for Survey is as mentioned below:

Grade	Duration	Start Time	End Time
Grade 3 and 5	90 Minutes	10:30 AM	12:00 PM
Grade 8 and 10	120 Minutes	10:30 AM	12:30 PM

4. Ensure that no other activities (such as Annual Function, Sports Day, Cultural Event, Exams etc.) is fixed on 12<sup>th</sup> November, 2021.
5. All the students of sampled grade (whether class 3, class 5, class 8 or class 10) must be present on the day of survey to ensure the smooth conduct of NAS.
6. The spirit of NAS and its underlying objectives must be explained to the HoS and teachers and others as have been articulated in the documents available on NAS portal <https://nas.education.gov.in/>
7. Survey includes Achievement Test (AT) and Pupil Questionnaire (PQ) which are to attempted and filled by the students of the sample batch. Sample batch standard size is 30.
8. Concerned subject teacher(s) of the Sampled Section must be present to fill the Teacher Questionnaire (TQ).
9. HoS of sampled schools has to fill up the School Questionnaire (SQ) and provide complete and factual data as sought in the Questionnaire.
