All Head of Schools of all Govt., Govt. aided, recognized private unaided schools and local body schools are advised to take such steps that no eligible minority student left-out for applying online in r/o aforesaid schemes. Further, all Head of Schools are requested to expedite the verification process to make "Nil" pendency for verification of applications in school login instead of waiting for last date for verification.

At last, it must be noted that all type of schools having UDISE Code must be KYC compliant and their INO must be Aadhaar Authenticated on NSP of Govt of India. In case, this instruction is not complied with then minority student of concerned school cannot apply for Pre/Post matric scholarship on NSP and their INO will not be eligible for online verification of online applications on NSP.
