CIRCULAR

Please refer to the earlier office letter having no.F1(168)/Misc/RCS/Comp-CC/2011/3304175 dated 02.09.2014 and subsequent circulars no. F1(188)/RCS/Comp-CC/2014/Part-I/Comcrs/1425-26 dated 09.09.2015, dated 15.11.2017 in reference to observation made by Delhi Cooperative Tribunal (DCT) in Appeal No.243/2011/DCT. DCT has given observation that- "this is high time for all the societies to have their own websites. We feel that if the proceedings or the notices to the members are uploaded on the websites, the litigation would decrease".

Therefore, to ensure the transparency and to have data of the societies online it is informed that, all societies may take initiative to DCT observation and create their own website and upload/update the following information on regular basis:- (I) Membership details like id no. Father/ Spouse name, Contact details, (II) Annual Audit Reports, (III) Annual Returns ,(IV) Election and detail of Management Committee including the mobile numbers & email- id etc. (V) AGM & Resolutions passed, (VI) if SGM held & resolution passed, (VII) MC meeting resolutions,(VIII) Public Notices, (IX) office address,(X) any other important information.

You are requested to submit URL/ Web address and desired information of your society in Google Form on the below mentioned link or through the Link available on the website of the Department
