I would like to draw your kind attention towards this office letters dated 24.01.2020, 12.07.2020, 17.02.2020, 27.08.2020, 15.09.2020, 22.10.2020 and 09.12.2020 referring to State Commissioner for Persons with Disabilities, GNCT of Delhi, Order dated 20.09.2019 (Copy enclosed) to calculate the backlog vacancies of PH category ex-cadre posts of Group- A, B and C posts in the prescribed proforma. The information sought therein is to be submitted through affidavit before the Hon'ble High Court, Delhi in WP(C) No. 8455/2017 in the matter of National Federation of Blind Vs. GNCTD and Ors.

The Hon'ble High Court, Delhi in the order dated 28.01.2020 (Copy Enclosed) has directed to submit the vacancy based roster in respect of PH category, As per DoPT OM No. 36035/02/2017-Estt (Res) dated 15-01-2018 every Government establishment is required to maintain 100 point vacancy based reservation roster register for determining/effecting reservation for persons with benchmark disability.

Despite repeated communication as evident above, the requisite information is still awaited. It will not be out of place to mention that the matter is scheduled for hearing on 12-02-2021 in the Hon'ble High Court of Delhi. Hence, any further delay in submitting response/affidavit can be viewed seriously by the Hon'ble High Court with consequential repercussions.

You are therefore, requested to look into the matter personally and direct the officer(s) concerned to provide the requisite information after getting it vetted from the office of State Commissioner for persons with Disability, to this department within 03 days of receipt of this letter.
