# STANDARD OPERATING PROCEDURE ON HELPLINE, SAFE HOUSE AND SPECIAL CELLS

### Introduction

The Hon'ble Supreme Court vide its judgment dated: 27.03.2018 in case titled as Shakti Vahini Vs UOI vide W.P.C. No. 231/2010 had directed the state to create Special cells in every district comprising of the Superintendent of police, the District Social Welfare officers and District Adi-Daridar welfare officer to receive petitions/complaints of harassment and threat to couples of inter-caste/inter faith marriages. These special cells shall create a 24 hour helpline to receive and register such complaints and to provide necessary assistance/advice and protection to the couple. Such safe house shall cater to accommodate (i) young bachelor/ bachelorette couples whose relationship is being opposed by their families/local community/Khaps and (ii) young married couples (of an inter – caste or inter- religious or any other marriages being opposed by their families local community /Khaps. Such safe house may be placed under the supervision of the jurisdictional District Magistrate and Superintendent of Police.

Procedure for intake of couple through helpline

- 1. 181 toll free women helpline, which is widely circulated and popular number among common public shall also serve as 24 hrs Helpline for the special cells to receive and register such complaints from inter-caste/interfaith married couples and to provide necessary assistance/advice and protection to the couple
- 2. The telecallers trained to handle distress calls and alreadyaware about available services can provide necessary assistance / advice to the couple in distress. If required, they can be further trained to handle such calls.
- 3. The infrastructure and office already in place under supervision of Delhi Commission for Women shall be utilized for said purpose of facilitation and intake.
- 4. Confidentiality of cases shall also be maintained as being done in calls of women in distress.
- 5. The SOP will be shared with the telecallers who shall assist the couples in distress in terms of referring the case to special cell in every district, Safe House, socio-legal counseling services, police facilitation, medical assistance, etc.

Mechanism for handling cases of distress couple/ Standard Operating Procedure is shown in the flow chart below:

### Details of processes involved;

- 1. After hearing the couple, it should be first ascertained whether the bachelor-bachelorette are adults to rule out involvement of minors. Thereafter, the DCPs in- charge shall take the following action:-
- a) A Complaint be taken from the couple and the enquiry be initiated at once.
- b) DCPs shall bring the entire facts in the knowledge of concerned District Magistrate and convey the requirement of the couple for their stay in "Safe House" if the facts so reveal and the couple in distress require the same.
- c) Adequate security shall be provided to the couple in form of PSO (Protective service officer) and the safe house be also secured by the concerned DCP of the area.
- d) The couple shall be briefed about the threat to them and in no case they be exposed till the issue is resolved.
- e) The initial enquiry regarding the complaint received from the couple or from an independent source that the relationship/marriage of such couple is opposed shall be marked to the officer of rank of Addl. DCP of Delhi Police of the concerned district. He/she shall conduct a preliminary enquiry and ascertain the authenticity of such threats and shall immediately submit a report to the DCP in not later than one week.
- f) The DCP on receipt of such report shall direct ACP/SDPO(Sub division police officer) concerned to register an FIR against the persons threatening the couple and it necessary, invoke section 151 of CrPC. Additionally, the ACP shall personally supervise the progress of investigation and shall ensure that the same is completed to its logical end with promptitude.
- g) In case the couple does not want to stay in such safe houses, the Special Cell shall provide the protection to them, as per the threat perception at Place of stay.

h) The concerned SHO/ACPs Sub-Division shall ensure safety and security of the couple immediately on receipt of information/complaint and if the need arises in case the threat in grave and the life and limbs of the couple is at risk.

### SAFE HOUSE

The GNCT of Delhi has established a Safe House at a govt. residential accommodation with an area of 60 Sq yards having two rooms and a toilet and kitchen at Kingsway Camp which can accommodate maximum three young bachelor/ bachelorette couples whose relationship is opposed by their families/ local community/khaps or young married couples (of inter caste or inter religious and other marriages opposed by their families/khaps.

More space is being provisioned at Poor House for Beggers, Kingsway Camp.

The Supdt, Blind Hostel, Dept. of Social Welfare shall be responsible for boarding and lodging facility for such couples and the expense therein will be incurred by the beneficiaries as decided by Superintendent and approved by Department using the Blind Hostel expenses. The arrangements shall be made as under:

- 1. Wooden beds with mattresses and bedsheets / bed covers
- 2. Meals(breakfast/lunch/dinner and tea in evening) as per the dept. manual
- 3. Maintaining duty roaster of staff deputed by police
- 4. Visitors register to be maintained strictly
- 5. Medical facility from the nearest hospital under the police protection
- 6. Counseling to couple family through probation officer deputed by the Chief Probation Officer.

### Others:

- Consent from the couple for staying in safe house shall be taken during intake.
- A security plan shall be prepared for the safe house by the Jurisdictional DCP.

### **Extra Budgetary Provisions :**

- a. The couple sometimes require clothing as they come without any luggage. Extra funds may be allocated to Supdt. (Blind Hostel) as per requisition.
- b. Transportation to pick the couple from the place of their call, (car or train) the expense shall be the duty of police.
- c. Extra medical Expenses (if required) shall be borne by Department of Social Welfare.

d. The tele-caller of 181 will be equipped to handle distressed calls of couple and assist accordingly.

### Legal Help

Free legal aid facility will be provided through Delhi State Legal Services Authority whereas Delhi Commission for Women will facilitate as a linkages for referring of calls for legal assistance' to DSLSA.
