These pension cases of pre-2016 pensioners are required to be revised in accordance to the O.M. No. 38/37/2016- P&PW (A) dated 12.05.2017 issued by the Department of P & P W, M/o Personnel, PG & Pension by notionally fixing their pay in the pay matrix recommended by the 7th CPC in the level corresponding to the pay in the pay scale/pay band and grade pay at which they retired/died.
