6.	Age Limit for direct recruits	Not Exceeding 30 Years. Note 1: Relaxable for Government Servant up to five years in accordance with the instructions or orders issued by the Central Government. Note 2: The crucial date for determining the age-limit shall be as advertised by the UPSC/ Competent Authority.
7.	Educational and other Qualification required for Direct Recruits	Essential: 1. Masters Degree in Urdu with English or Hindi as an elective subject at Degree level from a recognized University or equivalent. OR Masters Degree in Persian/ English/ Hindi with Urdu as an elective subject at Degree level from a recognized University or equivalent. 2. 5 years' experience of terminological work in urdu and /or translation work from English/Hindi to Urdu or vice-versa preferably of technical scientific literature in Government/PSUs/Autonomous Bodies/Corporations/ Universities.
