Subject:- Scheme for Regularization of Domestic Unauthorized Water Connection.

Reference circular No. DJB/DOR/Scheme/107/2015/2021/ dated. 26/07/2021 on the subject mentioned above. Board vide Resolution No. 1187 dated 26/10/2021 has revised new connection charges which includes installation of connection and water meter cost as circulated vide Office Order No. 72 dated 15/11/2021. Therefore, scheme for regularization will have charges as per new rates with immediate effect.

All JDRs/DDRs/ZROs and ACEs/EEs/AEEs are directed to regularize all unauthorized water connections immediately.

OFFICE ORDER NO. 72 DATED 15.11.2021

Subject :- Policy for installation of Connections by Delhi Jal Board and colony category wise fixed connection charges.

The Delhi Jal Board vide Resolution Board No.1187, Item No. 323 dated. 26.10.2021 has approved the policy of installation of New Water Connection of 15mm service pipe connections including water meter, O &M of Existing water Connections by DJB alongwith meter wherever required (except ITRON and ARAD water meter installed by water division having 7 year O & M) as communicated vide circular no. DJB/ M(WS)/2021/F-3/3105-3126 dated. 13.11.2021 by the office of Member (Water).

Further, Board has decided that:

- (i) installation charges of water Connection shall be divided category wise as per categorization of colonies for property tax by MCDs as under:

For Domestic connections :

S. No	Colony Category	New Connection Charges for water
1	A, B, C	Rs. 4000/-
2	D & E	Rs. 2000/-
3	F, G, H & Rural Villages	Rs. 1000/-

For Commercial connection charges shall be double of the domestic charges in respective colony category.

- (ii) Sewer connections will be approved automatically with the approval of water connections . No separate sewer connection charge will be levied.
- (iii) Defective water meter will also be changed by DJB (except ITRON and ARAD water meter installed by water division having 7 year O & M).

Infrastructure Charges wherever applicable will be levied and no other charges, advance, security, RR Charges, meter security etc. will be levied in new connection bill. Similar charges will be levied for regularization of connection during the ongoing scheme.

ZROs will sanction water connections and send daily list properly serial numbered in continuation, without waiting for payment from the consumer, to concerned EE/AEE(Maint.) for installation of connection and meter. Billing of new connections will start from the date of installation by the office of EE/AEE and for regularized connections from the date of regularization. Accordingly, automatic process in RMS for start of billing from the next day of payment/ due date will be removed and service agreement of connection in RMS to be activated on the date of installation by EEs/ AEEs office, manually by ZRO offices for billing purpose.

Further, wherever water meter is defective, concerned EEs/AEEs may be informed with details for the replacement of water meter.
