C I R C U L A R

Delhi Jal board has the onus to provide essential services of water and sewerage to the citizens of NCT of Delhi. It has come the notice that many agencies after getting the award of work are not performing as per the milestones and timelines of Contract Agreement. This results in time and cost overrun of the project and also affects the essential public service delivery of DJB.

To avoid such situations in future and to ensure that the essential public service delivery being done by DJB is maintained without any delay, it is hereby ordered.

- 1 All Chief Engineers / Addl Chief Engineers shall monitor the milestones and timelines of different agencies / contractors working under them as per the CA conditions.
- 2 If any agency or contractor is found not performing as per the CA conditions, Chief Engineer and ACEs apart from taking legal and contractual action against the agency can also refer the agency / contractor case to a Committee (being constituted herewith) to assess the performance of the contractors/ agencies in the ongoing projects of DJB. The case should have all the details of the work, default on the part of the agency and also action taken by the CE / ACE as per CA conditions.



3 The above Committee shall comprise of the following:

- i. Sh. Vikram Singh, Chief Engineer (Dr) Project I
- ii. Sh. DK Vaish, Chief Engineer (E&M)
- iii. Sh. Shukla, Consultant (Law)
- iv. Sh. KS Sharma, Consultant (Finance)

4 The above committee shall go through the case referred to by the Chief Engineers / ACEs and after taking all the inputs as required from CE / ACE into consideration, shall decide upon the performance of the contractor being satisfactory or unsatisfactory. If the performance is found unsatisfactory, the Committee shall issue order to bar the contractor to participate in the tenders / projects of DJB for one year starting from the date of debarment. The Committee shall decide upon any referred case within 10 days of it being referred.

5 Appeal against the order of debarment shall lie with the undersigned within one month of the issue of debarment order.
