DURING CURFEW PERIOD**


Madam/Sir,

This is with reference to DDMA Order No.500 dated 28.12.2021 regarding the permitted / prohibited / restricted activities as per "Level of Alert-I (Yellow)" specified in Graded Response Action Plan (GRAP), which has further some more additional restrictions to be imposed in Territory of NCT of Delhi vide order No.504 dated 04.01.2022 till further orders.

2. In this regard, it is to clarify that, considering the health and safety, Persons with Disabilities and pregnant women employees shall be exempted from attending the duties (related to essential as well as non essential services) in the office of Departments / PSUs / Corporations / Autonomous Bodies / Local Bodies of Govt. of NCT of Delhi during curfew period, but they shall have regular communication with their office through available mode of communication i.e. mobile phone, email etc. and they shall continue to work from home.
