Subject: Revised Exam Date Sheet for Departmental Examination in "Simple Accounts" for JEs(Civil)/JEs(E&M) rescheduled to be held from 18th Apr., 2022.

According to the existing policy, Junior Engineers (Civil)/(E&M) working on Regular Basis are required to qualify the Accounts Test, within a period of two year/or until they are provided at least four chances from the date of their appointments so as to qualify themselves for the grant of further annual increments, successful completion of probation period, MACP and further promotion.

To provide such opportunity at regular intervals, Examination in "Simple Account" is conducted twice in a year through CPWD. Since, 20.03.2017, it is now being organized for the 7th time and <u>scheduled to be held from 18thApr, 2022 (10.00 AM to 1.00 PM)</u>, As per the CPWD's Notification dated 22.02.2022 bearing letter No. 01/02/2021-Exam/08 issued by the office of CE(T&R)II Cum COE, National CPWD Academy (Exam Cell), Kamla Nehru Nagar, Hapur Road, Ghaziabad. The said notification is available on website of CPWD and it is also being uploaded on the website of DJB i.e. delhijalboard.nic.in., through this letter.

All the JEs(Civil)/JEs(E&M) working in DJB on regular basis are requested to go through said notification and the guidelines as mentioned hereunder and take necessary action accordingly;

- 8. Preparatory classes may be arranged by DJB for the candidates appearing in the Accounts Test, schedule for the same will be issued separately by the Office of AC(Training), DJB.
- 9. Assistant Commissioner (T), DJB has been appointed as Liaison officer to deal with the CPWD and to approve and forward the online applications to the Exam Cell, CPWD. Hence, to enable this office, all the Individuals/applicants are requested to get themselves registered on the provided link/url https:/cpwd.gov.in/demps/default.aspx and also furnish the desired detail to the Office of AC(T) in the attached format duly Verified and Signed by the DDO concerned under his Seal/Stamp along the Name and Mobile No., POSITIVELY, by the 25th March, 2022.
- 10. The candidates who have already applied for the above examination earlier and whose admit card has been generated need not to apply again. However, all fresh candidates and those candidates who had applied but whose admit card could not be generated due to various reasons need to reprocess their application again and remove the shortcomings.
