**CIRCULAR**

**Subject: Scheme for waiver of LPSC (Late Payment Surcharge) on conditional basis for both the Category-1(Domestic) & Category-II (Commercial) Consumers.**


The Delhi Jal Board in its meeting held on 10.10.2022 has approved vide Resolution No.1304 dated 10.10.2022 the Scheme for waiver of LPSC (Late Payment Surcharge) on conditional basis for both Category-1 (Domestic) & Category-II (Commercial) Consumers as per the details given hereunder: -

- 100% LPSC waiver will be applicable only for those consumers who will clear their outstanding arrears under LPSC waiver scheme on or before 31.12.2022.
- 75% LPSC waiver will be applicable for those consumers who will clear their outstanding arrears under LPSC waiver scheme during the period 01.01.2023 to 31.03.2023.

**Eligibility Criteria: -**

1. All the consumers as mentioned above will be eligible under the scheme irrespective of status of water meter (O.K., Unmetered, Stop and Meter Lock etc.).
2. Consumers shall be required to pay full payment of principal amount outstanding as on 30.09.2022 or later outstanding on the date of payment during the currency of scheme.
3. No LPSC will be levied during the currency of Scheme.
