It is submitted that matter to invite Scholarship application from SC students under post matric scholarship scheme for the F.Y. 2021-22 on e-district portal Delhi is under process and valid till 31-3-2022..

However as per the instructions of the Ministry of SJE Govt. of India, the verification process of the applications received under the said scheme is needed to be completed immediately, so that the students may be given the scholarship amounts latest by 31-3-2-22, since as per new instructions the state Govt. will paid the 40% amount of the scholarship directly in the bank account of the beneficiary and the rest 60% would be paid by the Centre.
