Respected Ka'am/sir,

Please refer to my DO Letters of even number dated 10th January 2022, 31st January 2022, 22nd February 2022 and 17th March 2022 regarding the Swachh Vidyalaya Puraskar 2021-22. The SVP 2021-22 was successfully launched on 12th January 2022 by Hon'ble Minister of State for Education, Dr. Subhas Sarkar.

As per the SVP portal, as on 31st March 2022, nearly 8 lakh schools in the Country have been registered for the SVP awards. The last date for registering by the Schools is 31st March 2022 and nearly half of the schools in the country have not yet registered for the SVP award. This Department has also received several requests from the states for extension of last date for Online submission of applications by the schools. Therefore, this Department has decided to extend the last date for self-registration and submission by the schools for SVP awards 2021-22 upto 15th April 2022. All other timelines for the awards will remain the same, as informed earlier.

You are therefore again requested to ensure that all the schools in the state register themselves and submit their application on SVP portal for SVP 2021-22 awards, well before the revised last date i.e. **15th April 2022**. It is also requested to make all the necessary arrangements for starting the evaluation process also.

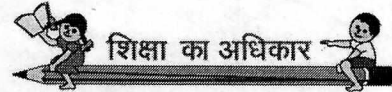
