3. Privacy of students/parents should not be affected in the process of project.
4. Material will not show any kind of advertisement i.e. name, sign, logo, sponsorship and material should not be distributed by any Celebrity.
5. There shall be no uploading of the image/pictures/video of the students on social media pages expect with the prior written permission of the Director (Education).
6. Organization has to ensure that no damages occur while conducting the program. It will be the sole responsibility of the Organization and it should rectify to the entire satisfaction of the HoS if there is any damage.
7. The permission is purely provisional and liable to be withdrawn at any time if it is found to be against the national interest or causes any type of obstruction in the functioning of DoE as well as violation of these terms and conditions.
8. The DoE will indemnify against any legal/financial liability/litigation that may arise out of the project process or its findings.
