**CIRCULAR**

**Subject: Regarding online verification of applications on e-district portal in r/o State Funded Scheme "Reimbursement of Tuition fees to the Minority Students of Classes I to XII" for 2020-21 and 2021-22**

Kind attention of all Head of Private Schools are drawn to the circular bearing No.DE. 18-(63)/PLG/2021-22/3582-3586 dated 29.04.2022 on the subject cited above. It is observed that still **heavy pendency** lies at the level of school/zone as on 9<sup>th</sup> May, 2022 which is adversely affecting the motto of Delhi Government regarding timely payment under the scheme to beneficiary student.

In this regard, all HoSs are requested again to ensure **NIL pendency by 12.05.2022** in r/o online verification of all applications on e-district portal in r/o "Reimbursement of Tuition fees to the Minority Students of Classes I to XII" for 2020-21 and 2021-22.

Further, all are informed that in case of non-clearance of pendency at the level of school/zone the **responsibility for the lapse of non-providing of reimbursement under the scheme to the minority applicant will lie on the concerned HoS/DDE(Zone) respectively.**

At last, all DDEs (Zones) are requested to submit a **certificate by 13/05/2022** declaring that the concerned zone and all recognized unaided private schools under the zone have NIL pendency regarding verification in r/o said scheme and all online applications have been verified as per guidelines of the scheme "Reimbursement of Tuition fees to the Minority Students of Classes I to XII" for 2020-21 and 2021-22.
