Subject : Summer Survey for identifying Out Of School Children (OoSC)

The summer break period in the Govt. schools of Delhi is from 11.05.2022 to 27.06.2022. Thus, during the summer break, it is proposed that STC Teacher's alongwith CRCCs will conduct an extensive survey to identify Out of School Children to enrol them in nearby schools.

The payment to STC Teachers shall be made for the above period. The team wise survey schedule will be prepared by the concerned DURCC and the same schedule will be shared with OoSC Cell of the Samagra Shiksha-Delhi by 11th May,2022.

The Survey teams will wear survey kit bearing identifiable official insignia which have been given to them for easy identification and gaining confidence of the people to get maximum information. They will report their daily survey records to the concerned DURCCs and the same record shall be mailed to OoSC Cell at Samagra Shiksha- HQ, Delhi, by 5:00PM on daily basis.

The complete report summary, duly signed by the concerned Coordination Team & countersigned by the DURCC will be submitted to the SS-HQ, Samagra Shiksha by the end of the survey by 4th July,2022 as per Annexure A & B attached.
