ORDER


Whereas, M/s Smat Forms was declared L-1 in the tender for printing and supply of Student Diaries for classes Nursery to 3rd & 4th to 12th for the A.Y. 2022-23 after opening of Technical bid and Financial bid respectively.

Whereas, Letter of Intent (LOI) was issued on 17.05.2022 to M/s Smat Forms vide which the said firm was to submit requisite documents i.e. Performance Security and other documents as per Tender clause no. 11(A) & 12 of e-tender within the stipulated period of 5 clear calendar days from the issue of letter of intent but the firm failed to submit the same.

Whereas, M/s Smat Forms was advised through e-mail sent by this office on 25.05.2022 to submit the requisite documents mentioned in the LOI by 26.05.2022 positively but M/s Smat Forms did not submit the required documents within stipulated period of time. Further, M/s Smat Forms was issued Show Cause Notice by this office on 27.05.2022 seeking clarification for not complying with the terms and conditions of the Tender documents. In reply to Show Cause Notice, M/s Smat Forms, vide their letter dated 28.05.2022 received in this office through e-mail dated 28.05.2022, stated that due to unexpected flood in the area of booking of paper and late delivery of paper raw material, the timelines for the start of contract/order should be revised and some time should be given for procurement of raw material and also requested for personal hearing for better understanding and clarification on timeline issues. After going through the clarification submitted by M/s Smat Forms vide their letter dated 28.05.2022, the undersigned found the same not satisfactory. Thereafter, this office issued Final Notice to M/s Smat Forms on 31.05.2022 to submit the requisite documents as per Tender clause but M/s Smat Forms failed to submit the same and in reference to this Final Notice, M/s Smat Forms repeated the similar statement as was mentioned by him in his reply dated 28.05.2022 and hence the clarification given by M/s Smat Forms not found satisfactory.

Whereas, the matter was further brought into the notice of higher authorities and a Notice dated 10.06.2022 was issued by this office with the prior approval of the Competent Authority where clarification was sought from M/s Smat Forms as to why M/s Smat Forms may not be debarred from participating in the tenders floated by DBTB. In response, M/s Smat Forms vide their letter dated 13.06.2022 stated that M/s Smat Forms is helpless in getting paper from mills due to unavailability in

specific given period. The said reply was examined and found unsatisfactory by the Competent Authority.

Therefore, after going through the clarification submitted by M/s Smat Forms and as per clause 41(6) of the tender document, the Competent Authority has decided to debar M/s Smat Forms from participating in any tender floated by DBTB, Dte. of Education, GNCT of Delhi for a period of two year

This issues with the prior approval of the Competent Authority.
