ORDER

Withdrawal of offer of appointment for the post of Physical Education Teacher Post Code 90/17 and cancellation the candidature in r/o Sh. Pravindra Singh, D.O.B. 04/09/1983, Roll No. 2700011697

Whereas, Sh. Pravindra Singh, D.O.B. 04/09/1983, Roll No. 2700011697 was provisionally nominated by the DSSSB for the post of Physical Education Teacher, post code 90/17 in Directorate of Education, Govt. of NCT of Delhi vide result notice no. 461 dated 30/05/2019 and accordingly an offer of appointment was issued to him vide No. F.DE.4(7)/DRC/E-IV/PET/2019/4066 dated 04/11/2020.

And whereas, the candidate has possessed the P.G. Diploma in Physical Education vide session 2005-2006 from Maharshi Dayanand University, Rohtak which is not the essential qualification for the post of Physical Education Teacher as per Recruitment Rules.


And whereas, As per advt. no. 04/2017 dated 20/12/2017 for the post code 90/17, the essential qualification for the post of Physical Education Teacher was "Graduate with Bachelor's of Physical Education (B.P.Ed.) or its equivalent"

And whereas the case was placed before the expert committee and after the examination of the case, the expert committee has decided that the candidate does not fulfill the essential qualification of B.P.Ed, strictly as per RR, hence he is not eligible for the post of Physical Education Teacher, under post code-90/17 and therefore his candidature for the post of Physical Education Teacher may not be considered

Therefore, the offer of appointment No. F.DE.4(7)/DRC/E-IV/PET/2019/4066 dated 04/11/2020 in r/o Sh. Pravindra Singh, D.O.B. 04/09/1983, Roll No. 2700011697, for the post of Physical Education Teacher, post code 90/17, is hereby withdrawn and the candidature stands cancelled.
