Sub: Replacement of Defective Flags supplied to General Public free of cost


Madam/Sir,

This is regarding Har Ghar Tiranga campaign, launched with the objective of invoking feeling of patriotism & belongingness with the National flag among Indian Citizens. The campaign entails hoisting/ display of flags by around 20 Crore households in the country. State/UT governments have made various arrangements for supply & distribution of flags to the general public.

2. In this regard, some complaints have been received on Social, Print & Visual media regarding defective flags being distributed to the public.
3. Therefore, I am directed to request you to kindly note the provisions of Flag Code of India including those prescribing the dimensions and proportions of the Flag. These provisions are to be followed strictly and defective flags should not be distributed among general public at any cost.
4. Further, in case any defective flags have been distributed, the same should be replaced immediately with a proper flag without any extra cost. Therefore, it is requested that State/UTs, may make arrangements for replacement of any defective flag supplied to General Public free of cost.
5. In addition, certain reports have been received, mentioning that Public is being forced to purchase Flags or that in some cases coercive measures are being adopted for flag distribution. In this regard it may be noted that Har Ghar Tiranga campaign is purely voluntary in nature and aims at evoking emotions of Patriotism and belongingness to the National Flag. Therefore, it should be ensured that no coercion of any sort is adopted for eliciting people's participation in the campaign. Necessary instructions may kindly be issued in this regard.
