CIRCULAR

SUB: Regarding certificate of Relieving as per Directorate of Education posting orders of recently promoted Assistant Teacher (Primary/Nursery of MCD) to the post of TGT vide Order No. DE.3(109)/E-III/Promotion/2021/1969-78 dated 29.07.2022 and posting order no. DE.3(109)/E-III/Promotion/2021/1969-78 dated In pursuance of promotion order no. DE.3(109)/Eorder no. 29.07.2022 and consequently posting III/Promotion/2021/2188,2189,2190,2191,2192,2194 dated 25.08.2022 the District Level Screening Committee has been constituted by District West-A for checking/Verification of original documents of the newly promoted Assistant Teacher(Primary/Nursery of MCD).
