**SUBJECT: Guidelines/Instructions for the admission of the candidates under EWS/DG category for fresh applications against remaining vacant seats at entry level classes (Nursery/Pre-school, K.G/Pre-primary & Class-I) for the academic session 2022-23.**

The Directorate of Education has already conducted main computerized draw of lots excluding adjustment round for the admission under EWS/DG & CWSN category at the entry level classes for the session 2022-23 in Private Unaided School (except minority schools) recognized under DSEAR 1973 & under RTE Act 2009.

Despite inviting online applications against the available seats vide circular dated 09/03/2022 approximately 10329 seats are still vacant. Hence, department has decided to call fresh online application again from the aspirants under EWS/DG & CWSN category against these available vacant seats at present. List of schools with available vacancies/seats will be available on departmental website [www.edudel.nic.in](http://www.edudel.nic.in) from 03/10/2022 at 11:00 AM.


Schedule for above online admission process is mentioned below:-

Last date of submission of online application by the EWS/DG & CWSN Category.	10/10/2022 (Monday) upto 5:00 PM
Tentative date & time of online computerized draw of lots	14/10/2022 (Friday)
