Subject: Revised timeline for various scholarship schemes on National Scholarship Portal for minority community students for the academic session 2022-23.

Kind attention is invited to our earlier circulars dated 04.08.2022, 26.08.2022, 29.08.2022, and 09.09.2022 regarding launching of CSS schemes & verification of applications under various Scholarship Schemes for minority communities on National Scholarship Portal for the academic session 2022-23. In this regard, Ministry of Minority Affairs (MoMA), GoI has issued the following revised timeline for Scholarship Schemes for the year 2022-23:

A review meeting was convened under the Chairpersonship of Deputy Commissioner-III(HQ), Revenue Department, Govt of NCT of Delhi on 30/09/2022. During the meeting the Chairperson showed strong displeasure on the very poor status of verification of applications and directed to verify all applications pending at INOs level at the earliest possible. The consolidated status report and Major issues raised by Revenue Department are attached herewith for reference.

At last, Head of all type of Schools are requested to arrange effective dissemination of information regarding launching of schemes on NSP so that eligible students may apply within the time limit of respective scheme and **also ensure that their INO must expedite verification process at Institute level so that no application remains pending for verification. In case, if any single application remains unverified then the eligible student will be deprived of their scholarship benefit and its responsibility will be lie on the concerned Head of School.**
