**SUB : Clarification regarding Educational Documents in r/o Smt. Bhavna Malik Kalra, Assistant Teacher (Primary) of MCD School in connection with promotion to the post of TGT in Directorate of Education.**

In pursuance of promotion order no. DE.3(109)/E-III/Promotion/2021/1969-78 dated 29.07.2022 and consequently posting order no. DE.3(109)/E-III/Promotion/2021/2188,2189,2190,2191,2192,2194 dated 25.08.2022 the District Level Screening Committee has been constituted by District West-A for checking/Verification of original documents of the newly promoted Assistant Teacher(Primary/Nursery of MCD). The District Level Screening Committee has checked/verified the documents of 31 Primary/Nursery Teachers posted in the District West-A vide Circular No. DE.3(109)/E-III/Promotion/2021/2188,2189,2190,2191,2192,2194 dated 25.08.2022.

During verification of documents, some queries were raised by the Screening Committee in r/o 07 teachers including the name of Smt. Bhavna Malik Kalra, Assistant Teacher (Primary) of MCD School and subsequently, the clarifications were sought from the E-III Branch, Directorate of Education. Now, the E-III Branch, Directorate of Education has clarified vide letter no. F. DE.3(80)/E-III/Promotion/Misc./2022/2735 dated 07/10/2022 in respect of Smt. Bhavna Malik Kalra that her case is not fit for promotion, mentioning therein **"Ms. Bhavna Malik Kalra has studied B.El.Ed with M.A (Education) instead of B.ED/M.ED. As per existing RRs of TGT/TGT(MIL) she found unfit for promotion to the post of TGT(Maths)."**
