CIRCULAR

Subject: Pendency of applications at INOs level under Centre Sector Scholarship schemes for minority community students at National Scholarship Portal for the academic session 2022-23.

Kind attention is invited to our earlier circulars dated 04.08.2022, 26.08.2022, 29.08.2022, 09.09.2022, 11.10.2022, 18.10.2022 and several e-mail sent time to time regarding launching of CSS schemes & verification of applications under various Scholarship Schemes for minority communities on National Scholarship Portal for the academic session 2022-23. In this regard, the Ministry of Minority Affairs (MoMA), GoI has extended the last date to verify the applications under Post-Matric Scholarship Scheme for Minority at INO's level up to **31st December, 2022** for the year 2022-23.

Further, Head of all type of Schools are requested to arrange effective dissemination of this information regarding revised timelines of Post-Matric Scholarship Schemes i.e. 31st December, 2022 on NSP to verify the pending application under this scheme at Institute level (L-1). **As per National Scholarship Portal, still 308 applications (259 Fresh applications+ 49 Renewal applications) are pending for verification at Institute level (L-1).** In case, if any single application remains pending at INO's level then the eligible student will be deprived of their scholarship benefit and its responsibility will lie on the concerned Head of School/INO.
