The undersigned is directed to refer to this Department's O.M. No. 1/3(1)/2008-E.II(B) dated 7<sup>th</sup> April, 2022 on the subject mentioned above and to say that the rate of Dearness Allowance (DA) in respect of employees of Central Government and Central Autonomous Bodies who are continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 6<sup>th</sup> Central Pay Commission, shall be enhanced from the existing rate of 203% to 212% of Basic Pay w.e.f. 01.07.2022.

2. The provisions contained in paras 3, 4 and 5 of this Ministry's O.M.No.1(3)/2008-E.II(B) dated 29<sup>th</sup> August, 2008 shall continue to be applicable while regulating Dearness Allowance under these orders.

No. 1/3(1)/2008-E.II(B) dated 7<sup>th</sup> April, 2022 on the subject mentioned above and to say that the rate of Dearness Allowance (DA) in respect of employees of Central Government and Central Autonomous Bodies who are continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 5<sup>th</sup> Central Pay Commission, shall be enhanced from the existing rate of 381% to 396% of Basic Pay w.e.f. 01.07.2022.

2. The provisions contained in paras 3, 4 and 5 of this Ministry's O.M.No.1(13)/97-E.II(B) dated 3<sup>rd</sup> October, 1997 shall continue to be applicable while regulating Dearness Allowance under these orders.
