OFFICE MEMORANDUM

Subject: "Covid Vaccine Amrit Mahotsav"-reg

I am directed to invite your kind reference to the captioned subject. Government of India has launched a new initiative of 'Covid Vaccine Amrit Mahotsava' from 15th July 2022 to 30<sup>th</sup> September 2022 (75 days) to provide free Precaution Dose to all eligible population at Government COVID Vaccination Centers (CVCs). All persons of 18 years and above who have completed 6 months or 26 weeks from the date of administration of 2nd dose are eligible for the free precaution dose.

2. Being implemented in a 'Mission Mode' this special COVID vaccination drive is a part of the celebration for 'Azadi ka Amrit Mahotsav'. It is requested to direct ICDS functionaries, Anganwadi workers, Service Providers in Child Care Institutions, Women's Homes and Working Women's Hostel in respective States / UTs to identify eligible beneficiaries and also to mobilize the beneficiaries for the Precaution Dose of COVID Vaccine under the Covid Vaccine Amrit Mahotsav.

3. Details of precaution doses administered during the period mentioned above may be provided by States/UTs in the 'Covid Vaccine AKAM Whatsapp Group' be created for this purpose.
