

Further, it is also requested that all the officer/officials appointed under Sports Quota and presently working in your department may be directed to report for trial, for the game/event on the basis of which he /she was appointed in Govt. Service.

The trials shall be made strictly on the basis of instructions issued by the Central Civil Services and Sports Board, Government of India. The officers / Officials working under the cadre control of Government of NCT of Delhi and professional Coaches although designated like Sports Officers, instructors etc. employed in Physical Training Institutions etc. on permanent basis are eligible for participation in these trials. One officer/ Officials will be selected as probable player in One Game only. However, the officers/official working in autonomous bodies/local bodies/corporation either on deputation or regular basis viz like DFC, DJB, DTC, DDA, MCD, NDMC, Delhi Police etc. are not eligible for participation in the trials.

On selection as probable player, it is directed to submit the permission of the concerned Head of Department/competent authority for participation in the practice camp. This permission performa/letter will required to be submitted within 10 working days of the issuance of selection order, failing which next player in the merit will be considered for selection as probable player. The performa will be available on the web-site of this department.

All Head of Departments, Govt. of NCT of Delhi are requested to circulate this trial schedule among all the officers/officials working in their departments. Interested officers/officials may also be allowed to report for trials at the venue as per schedule.


