To usher in reforms in the legal system and make it more accessible to the common people, a comprehensive review to identify obsolete Laws/Acts has been undertaken since 2014. Consequently, 1486 such Acts have been repealed.

2. To carry the process forward, Parliamentary Standing Committees are being requested to identify obsolete Acts in consultation with administrative Ministries under their purview. In addition, it is equally important to examine specific provisions of existing Acts, to identify if there is a need to repeal/modify any specific provision that may help improve governance and ease of living.

3. I would, therefore, request you to initiate immediate and effective steps in your Ministry/Department for reviewing the utility of existing Acts and Subordinate Legislations to address the aspects mentioned above and take the exercise to its logical conclusion.
