Subject:- Delegation of Powers.

In exercise of its powers under Section 22 of the Delhi Water Board Act, the Board in its 164th meeting held on 11th January, 2023 has considered the proposal contained vide Dir. (F&A) No.DJB/Dir(F&A)/2023/1386 dated 10.01.2023 and resolved vide Resolution No.1323 Item No. Admn.621 to approve the following delegation:-

1. Vide order No.DJB/Fin./Dir.(F&A)/DD-II/Sr.AO(F&G)/DFP/2022-23/1292 to 1309 dated 09.11.2022 of Director (F&A) the power was delegated at Srl. No.4 regarding "sanction of excess over awarded cost/extra/substitute items/ deviation in quantities of agreement items" vide Resolution No.1312 Item No.Admn.617 dated 07.10.2022. The Board has now approved that the word "Deviation in quantities of agreement items" be deleted from all the authorities to which power was earlier delegated. Now, Deviation shall be dealt by respective authorities as per Contract Agreement.
2. Vide order No.DJB/Fin./Dir.(F&A)/DD II/Sr.AO(F&G)/DFP/2022-23/1292 to 1309 dated 09.11.2022 of Director (F&A) the power was delegated at Srl No.12 regarding "Award of work without call of tender/ Spot quotation" vide Resolution No.1312 Item No.Admn.617 dated 07.10.2022 delegated to ACE(M) only. The Board has now approved that this part "For ACE(M) cases up to 5 lakh (not exceeding 7 cases per month)" would be executed by Chief Engineers also.

This issues with the prior approval of the Competent Authority.
