TERMS & CONDITIONS

1. The Muster Roll workers shown in the list will henceforth be covered under this sanction and their serial number should be noted while dealing in official capacity in future.
2. The Muster Roll workers covered in the list will not be re-engaged or taken on duty, if they remain absent for 30 or more days continuously, without the specific sanction from the Competent Authority i.e. Member (Administration), Delhi Jal Board.
3. Mere appearance of one's name in the list does not make one entitled for muster roll wages. The controlling authority has to further ensure that the worker is presently working on Muster Roll and if a worker has been regularized or is running absent or no more on muster roll due to any reasons, whatsoever, his wages will not be released by the controlling officer and this fact will be reported to this office.
4. This sanction is not applicable in case of those Muster Roll workers who have engaged to perform work for a limited period for seasonal nature of work in different years.
