- h. Affidavit regarding creamy layer (for OBC candidates only)
- i. Proof of present & permanent address
- j. Certificate of disability issued by the competent authority (if applied in the category of Persons with Disabilities)
- k. Two recent passport size photographs (one should be self attested)
- I. Photo Identity Card (Preferably Aadhar Card)
