CIRCULAR

Kind attention is invited to the D.O. F.11 (353)/SCH/DSCST/17497 dated 03.03.2023 received from Secretary, Department for the Welfare of SC/ST/OBC, GNCTD addressed to Director (Education) regarding receiving of less number of applications so far in 2022-23 as compared to previous years and pending of applications for verification at L-1 (school level) and L-2 (Zone level) in 2017-18 to 2022-23 under various welfare/scholarship schemes for SC/ST/OBC students implemented by the Department for the Welfare of SC/ST/OBC, GNCTD.

In this regard, despite of several repeated requests and convening of a virtual meeting by the Director (Education), the number of applications received as on date is very less as compared to AS 2021-22 and still 15805 applications at L-1 (school level) and 3667 applications at L-2 (Zone level) are pending for verification in AS 2022-23 (current status attached). Unfortunately, some applications are still pending at both the level in AS 2017-18 to 2021-22.

In view of the above, all the DDE (Districts and Zones) are hereby requested to instruct all HoSs of Govt./Aided/Unaided Private schools under their jurisdiction to disseminate information regarding various scholarship schemes earmarked for marginalized groups through extensive awareness programme by the following means:

1. By disseminating information to the students through Class-Teachers
2. By announcing details of schemes in Morning Assembly
3. By sensitizing parents through SMC members
4. By setting-up of a Help-Desk

In addition to this, all DDEs, Zones and Heads of Govt./Govt. Aided/Recognized Unaided Pvt. Schools of respective zones/districts are hereby directed to verify the applications already received in their login on e-district portal without waiting for the last date i.e. **31.03.2023** for A.S. 2022-23 and also complete verification of pending applications of all welfare/scholarship schemes for the years 2017-18 to 2021-22 at the earliest so as to enable DSCST to process these cases further and make/facilitate payment of welfare/scholarship benefits to the beneficiaries.
