CIRCULAR

**SUBJECT: Guidelines for admission of CWSN Category 'Students in Private Unaided Schools of Delhi Recognized under RTE Act and DSEAR Act by Govt. of NCT of Delhi at Entry Level Classes for the academic session 2023-24 selected through 2nd Computerized Draw of Lots.**

This is with reference to circular No.DE 15 (1025)/PSB/2023/4535-4538 dated 17/05/2023 through which online applications were invited for 2<sup>nd</sup> computerized draw for admission of CWSN candidates at entry level classes (Nursery, KG & Class-I) in Private Unaided Recognized Schools (except minority schools) of Delhi for the academic session 2023-24.


The 2<sup>nd</sup> Computerized draw of lots for Online Applications received from CWSN Category students for admission at the Entry Level Classes (Nursery/Pre-School, KG/Pre-primary, Class-I) has been successfully conducted on 07/06/2023 (Wednesday).

Further, vide this Directorate's circular dated 02.02.2023 and 14.03.2023, wherein detailed guidelines were issued regarding admission under EWS/DG/CWSN category students in Private Unaided Recognized Schools of Delhi.

In addition to the above mentioned detailed guidelines, it is clarified that, Private Unaided Recognized Schools are allotted through computerized draw of lots from the choices of school filled online by the parents with respect to the specific residential address. However, if there is any deviation in the residential address documents at the time of the admission from the residential address filled online, the school allotment shall stand cancelled.

The successful applicants shall approach the school allotted through computerized draw of lots **on or before 30/06/2023 (Friday)** up to 1 PM during school hours along with the documents as mentioned in the circular dated 14/03/2023.
