CIRCULAR

Subject: Disposal of scholarship applications under Pre & Post-Matric Scholarship Schemes for SC/ST/OBC students for FY 2022-23

This is in continuation of this branch circular dated 15.06.2023 & 23.06.2023 regarding the subject cited above. All concerned are informed that a meeting was convened on 25.07.2023 under the Chairmanship of Joint Director (Scholarship), Department for the Welfare of SC/ST/OBC (DSCST) to monitor the progress made and to discuss the several issues for non-clearing of pending applications at both levels (L-1 & L-2). During the meeting, Joint Director (Scholarship), DSCST has expressed his strong displeasure on dismal status of verification of pending applications under "**Post-Matric & Pre-Matric scholarship scheme for SCST/OBC students**" on e-district portal for the year 2022-23 and directed to verify all applications pending at both levels (L-1 & L-2) before **27.07.2023** positively.

In this regard, after issuing many circulars, emails & messages on WhatsApp group still 450 applications (at school level) and 371 applications (at zone level) are pending for verification for the Academic Session 2022-23 as on 25.07.2023 under the "**Post-Matric & Pre-Matric scholarship scheme for SC/ST/OBC students**" on e-district portal.

In view of the above, all DDEs (Zone) and Heads of Govt./Govt. Aided/Recognized Unaided Pvt. Schools are hereby directed to **complete verification of pending applications under all scholarship schemes on e-district portal for the year 2022-23 latest by 27.07.2023** so as to enable DSCST, GNCTD & Ministry of Social Justice & Empowerment (MoSJ&E), Govt. to process these cases further and make/facilitate payment of welfare/scholarship benefits to the applicants well in time. **In case, any single application remains pending at Zone level (L-2) or School level (L-1) then the concerned Officer/Official will be held responsible for the lapse.**
