**Circular**

**Subject: Computerized draw of lots for "in waiting candidates of EWS/DG category" at entry level (Nursery, KG & I) of session 2023-24, in all Private Unaided Recognized Schools (except Minority schools) under the Directorate of Education, Govt. of NCT of Delhi only.**

1. As per Section 12(1)(C) of RTE Act, 2009, all Private Unaided Recognized Schools (except Minority schools) are under obligation to admit at least 25% of declared strength of entry level class/classes by children belonging to Economically weaker section, Disadvantaged group and CWSN in neighborhood and provide free and compulsory elementary education till completion of elementary education.
2. Further, the Directorate of Education started the process of online allotment of seats in EWS/DG/CWSN category by computerized draw of lots at the entry level of class/classes in the Private Unaided Recognized school (except Minority) recognized under DSEAR Act & Rule 1973 in year 2016-17, and from year 2018-19 it was further extended in Private Unaided Recognized school (except Minority) recognized under RTE Act, 2009.
3. The department has conducted 1st computerized draw of lots on dated 14.03.2023 for admission under EWS/DG/CWSN Category at entry level classes in Private unaided Recognized Schools of Delhi and 2<sup>nd</sup> computerized draw of lots on dated 12.05.2023.
4. To resolve the grievances of students kept in waiting till date the Directorate of Education has decided to open link of online application in the welfare of In-waiting candidates EWS/DG category to submit fresh preferences of choices of school from the available vacancies to resolve grievances of the kept in waiting for so long by Private Unaided Recognized Schools (except Minority) on pretext of less number of admission in General Category.
5. In view of the above, In waiting candidates EWS/DG category can now submit a fresh preferences of choices of school in the original application of admission from the available vacancies in Private Unaided Recognized Schools of Directorate of Education only w.e.f. 20/10/2023 to 26/10/2023 (5.00PM) and computerized draw of lots will be held thereafter.
6. Further, In waiting candidates EWS/DG category may access the Directorate of Education's website i.e. [www.edudel.nic.in](http://www.edudel.nic.in) and click on "EWS/DG Admission" link available on home page for submission of fresh preferences of choices of school in the original application of admission.
