Healthy people are the foundation for healthy economies. A significant portion of the global population still lacks access to vital healthcare services. The Sustainable Development Goal 3 makes a bold commitment to achieve universal health coverage, and provide access to safe and affordable medicines and vaccines for all. Various determinants of health, including environmental and commercial factors, need attention to pave the way for achieving our common objective of Health for All and achieving the Sustainable Development Goal target.

The editorial team has decided to raise awareness in community about the importance of good health, healthy lifestyles as well as people's right to quality health care services. The theme of the December-2023 edition of the magazine will be "Good Health & Well-Being".

The Scholarly articles/ideas/works within the under mentioned parameters are invited from all the above category of stakeholders to be considered for publication in December-2023 edition of the magazine –

(i)Language: Hindi (font Mangal, size 11) or English (Times New Roman, font size 11)

(ii) Word Limit: 500 to 2000 words

(iii) The articles should be self work/idea, clear, concise & student oriented. The articles

should also include tables, diagrams & pictures wherever necessary.

- (iv) Common & simple language should be used in your work.
- (v) The title of the article/synopsis should adequately represent the content of the paper.
- (vi) References should be mentioned at the end of the article.

Articles/ideas under the following heads may be considered for publication: (A) <u>Editor's Choice (संपादक की पसंद)</u>

The Stakeholders can write articles under this head. Articles written under this head must align with the theme '**Good Health & Well-Being'**. Writers must use original research, anecdotes, challenges & solutions.

(B) Innovations(Students/Teachers (नई खोज)

The Students & teachers can write about the innovations done for spreading awareness in community about the importance of good health, healthy lifestyles as well as people's right to quality health care services.

(C) Mentor's Intervention (सफल पथप्रदर्शक की उपलब्धियां)

The Stakeholders who has/have mentored a project & achieved good result related to the theme 'Good Health & Well-Being'.

(D) Trending News in Science (विज्ञान के नवीनतम समाचार)

This section will focus on latest trending news in science & technology. It should contain synopsis of main headlines that are trending. It must have minimum 5 headlines, quoting leading newspapers, research, journals, social media coverage, etc. References should be given at the end of the article.

(E) Brain Mapping (सुलझाओ तो जाने)

This section will cover brain teasing puzzles, quizzes, crosswords, Sudoku, jumbled words, etc. Stakeholders writing for this section will also provide solution.

(F) Science Fiction(विज्ञान-कथा)

This section will deal with imaginative and futuristic concepts such as advanced science and technology, space exploration, time travel, parallel universes, and extraterrestrial life.

(G) Forthcoming Exams (आगामी परीक्षाएं)

This section will alert students & teachers regarding coming exams in Science & Technology. Stakeholders should write short notes about different exams coming in between December-2023 to February-2024.

(H) Book Review (पुस्तक समीक्षा)

The Stakeholders can write book review of any one book which is inspiring, biography of any eminent scholar/scientist or any such book that can be recommended for reading.

(I) Fun Facts (विज्ञान के रोचक तथ्य)

The Stakeholders should write scientific facts which are weird/amazing but true.

(J) Our Environment Our Responsibility (पर्यावरण हमारा उत्तरदायित्व)

This section is based on innovative steps taken to achieve affordable & clean energy. The article under this head must be supported by photographs/visuals.

(K) Kids Corner (विज्ञान के रोचक तथ्य)

The Stakeholders can write simple scientific games/tricks that students can develop at home.

(L) Journey of a Scientist (एक वैज्ञानिक की सफल यात्रा)

The Stakeholders can write under this heading regarding success story of an eminent personality working/worked in the field of 'Good Health & Well-Being'.

All the stakeholders shall have to submit their write-ups **latest by 21st November**, **2023** using the google link <u>https://forms.gle/cDg1mfMVj7FQCyKV7</u>. Students shall submit their entries only after counter signature of the Head of the School(HOS) on the prescribed undertaking attached with the above link.

The District wise responses received shall be shared with the District Committee on **24th November, 2023** & further District Committee will scrutiny & finalise one entry each under the heading (A) to (L) as mention above. All the write-ups recommended by the district review committee & endorsed by DDE(District) should be submitted latest by **30th November, 2023** @ <u>doesciencemagazine@gmail.com</u>.

The District Level Committee shall also ensure that the entries received from stakeholders of Govt. Aided Schools & Private Unaided Schools of DOE must be considered at par with Govt. Schools.
