Cancellation of offer of Appointment and candidature to the post of PGT(MATHS) MALE, POST Code 28/20.

Whereas, **Sh. Mujahid Husain, D.O.B. 05/06/1989, Roll No. 121202800095** has been nominated by the DSSSB to the post of PGT(MATHS)-MALE against Post Code 28/20 vide Result Notice No.855 dated 10/05/2022 in the Directorate of Education, Govt. of NCT of Delhi.

And whereas, **Sh. Mujahid Husain** was called for document verification vide memorandum letter no. 897 dated 16th May 2023. He appears for document verification on 31.05.2023 and during the course of verification of documents, following deficiencies were observed:

- 1) Undertaking regarding completion of B.Ed. in 3 years after joining the service.
- 2) Mother's name in marksheets (UG).
- 3) N.O.C. required being in Government Service.

And whereas, the candidate was issued deficiency memorandum vide even no. 3648 dated 31/05/2023, email dated: 02/06/2023, no. 1340 dated 21/06/2023 (Reminder) and no. 1467 dated 17/07/2023 (Final-Reminder) to submit the requisite documents/clarification as mentioned in the deficiency memorandum.

And whereas, Sh. Mujahid Husain on dated 01/08/2023 submitted requisite documents as mentioned in deficiency memorandum S.No.1 & 2 except deficiency mentioned at S.No. 3.

And whereas, Sh. Mujahid Husain did not submit/reply the requisite document in response to aforesaid deficiency at S.No. 3. He were issued 03 reminders vide even no. 1606 dated 04/08/2023, no. 1742 dated 06/09/2023 (Reminder-II) and no. 2087 dated 08/11/2023 (Final-Reminder).

As per DOPT OM no. 35016/2/93-Estt.(D) dated 09.08.1995, the following has been mentioned:

"An offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however with the specified period a request is received from the candidate for extension of time, It may be considered by the Ministry/Department but extension beyond 3 months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum period of 6 months from the date of issue of original offer of an appointment". An offer of appointment would lapse automatically after the expiry of 6 months from the date of issue of the original offer of appointment.

Therefore it is evident that the candidate is no longer interested in joining the above mentioned post. Hence, the Director (Education) being the Competent Authority ordered to **cancel** the candidature of **Sh. MUJAHID HUSAIN, D.O.B. 05/06/1989, Roll No. 121202800095, post PGT (MATHS)-MALE** and return his dossier to the DSSSB.

This issues with the prior approval of the Competent Authority.
