Subject:- Application for New NCC Units raisings.

The NCC Directorate vide letter no. 2015/11/Trg/Policy received from joint Director Training-I NCC Directorate Delhi, 1st Floor NCC Bhawan Sector-19, Rohini, New Delhi -110089 dt. 17.10.2023 has requested to circulate the necessary information among the schools under DoE, regarding new raising of NCC and all applications received henceforth for new raising of NCC will be redirected to NCC Dte. Delhi. Alternately, the school/College authorities will be advised to approach NCC Dte Delhi for new raisings, along with their application.

Based on the geographical location of the institution, unit vacancies & area of responsibility, the institution will be redirected to its prospective Gp HQ/Unit.

The Unit CO shall coordinate with the institution & carry out a visit in person to that institution for analysing / confirming its suitability for allotment of NCC, within 15 days of receipt of letter from NCC Directorate.

The unit shall inform NCC Dte. Delhi & its Gp HQ the suitability/ non-suitability of the institution (with reason) post – visit in writing. Only after that, it found suitable the institution shall be entered in waiting list or asked to forward a formal application as per format (if no waiting list exists) for raising NCC.

In this regard, all the HOSs of Govt./ Govt. Aided/Pvt. Schools are requested to submit applications regarding new raising of NCC for their respective schools to NCC Dte. as mentioned under:
