CIRCULAR


With reference to an e-mail dated 8th December, 2023, seeking permission to conduct (free of cost) online Maths Quiz Competition with the support BHANZU organization in all the schools of Delhi, the competent authority has granted permission with the following terms and conditions.

1. The schools working should not be disrupted. The safety and security of the students should be ensured.
2. Financial aid will not be provided by the Directorate of Education School (or) Student to the concerned Organization (or) any person. Moreover, no foreign funding should be involved in the project without following the guidelines issued by GoI.
3. Privacy of students/parents should not be affected in the process of project.
4. Material will not show any kind of advertisement i.e. name, sign, logo, sponsorship and material should not be distributed by any Celebrity.
5. There shall be no uploading of the image/pictures/video of the students on social media pages expect with the prior written permission of the Director (Education).
6. Organization/Researcher has to ensure that no damages occur while conducting the program. It will be the sole responsibility of the Organization and it should be rectified to the entire satisfaction of the HoS, if there is any damage.
7. The permission is purely provisional and liable to be withdrawn at any time, if it is found to be against the national interest or causes any type of obstruction in the functioning of DoE as well as violation of these terms and conditions.
8. The DoE will indemnify against any legal/financial liability/litigation that may arise out of the project process or its findings.
9. The programme will be run under the supervision of the designated teachers.

Therefore, the HoSs of all the Government schools are hereby directed to allow the Routes 2 Roots representatives to guide the students for registration process and details of the Maths Quiz Competition in their schools, also designate a teacher as Programme Coordinator (TGT Math).

The interested HoSs of Government Aided/Private Unaided Recognized schools are also requested to allow the Routes 2 Roots representatives for the same.


