

Subject:- General recommendations of the Competent Authority regarding Global Tender Enquiry (GTE) proposals regarding.

Kind reference is invited to the Global Tender Enquiry (GTE) meeting held on 27th October, 2023 at 10:00 AM under the Chairmanship of Secretary (C) with D/o Expenditure and D/o Promotion of Industry and Internal Trade to discuss the GTE proposals of various Administrative Ministries / Departments.

2 In this regard, the undersigned is directed to convey the following general recommendations made by the Competent Authority in the above-mentioned meeting:

- i) DoE may advise to all Ministries / Departments having GTE proposals pending with them for more than 03 months to expedite their decision regarding these proposals.
- ii) DPIIT may request action taken report (ATR) from various Ministries / Departments in compliance of the general recommendations made by the Competent Authority from time to time in GTE meetings. Summary of the ATR on all recommendations made till 30/09/2023 may be submitted to this Secretariat by 30/11/2023 and by the last day of the month following each quarter of the financial year.
- iii) DPIIT may review and monitor (on monthly basis) progress of indigenization of those items which were agreed to by the CA with reduced quantity and examine the status of developmental orders in such cases placed by the procuring entities with local manufacturers/service providers. DPIIT is to submit quarterly report to the CA at the beginning of every quarter by the end of the following month. The first presentation in this matter will be made by DPIIT in 1st GTE meeting of January, 2024 which should include the details of such GTE proposals considered till 30th September, 2023.
