

The undersigned is directed to refer to this Department's O.M. No. 1/3(1)/2008-E II(B) dated 10<sup>th</sup> April, 2023 on the subject mentioned above and to say that the rate of Dearness Allowance (DA) in respect of employees of Central Government and Central Autonomous Bodies who are continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 6<sup>th</sup> Central Pay Commission, shall be enhanced from the existing rate of 221% to 230% of Basic Pay w.e.f. 01.07.2023.

2 The provisions contained in paras 3, 4 and 5 of this Ministry's O.M:No.1(3)/2008-E II(B) dated 29<sup>th</sup> August, 2008 shall continue to be applicable while regulating Dearness Allowance under these orders

**Subject: Revision of rates of Dearness Allowance to the employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pay scale as per 5<sup>th</sup> Central Pay Commission**

The undersigned is directed to refer to this Department's O.M. No. 1/3(2)/2008-E.II(B) dated 12<sup>th</sup> June, 2023 on the subject mentioned above and to say that the rate of Dearness Allowance (DA) in respect of employees of Central Government and Central Autonomous Bodies, who are continuing to draw their pay in the pre-revised pay scale as per 5<sup>th</sup> Central Pay Commission, shall be enhanced from the existing rate of 412% to 427% of Basic Pay w.e.f. 01.07.2023.

2. The provisions contained in paras 3, 4 and 5 of this Ministry's O.M.No.1(13)/97-E II(B) dated 3<sup>rd</sup> October, 1997 shall continue to be applicable while regulating Dearness Allowance under these orders.
