**CIRCULAR**

The Labour Department, GNCTD has sought clarification from MoLE, Govt. of India regarding registration of Trade Union/Federation of Trade Union having all India Jurisdiction by Registrar Trade Union Delhi. The Ministry of Labour & Employment vide letter dated 07.07.2023 has informed as under:-

(a). *As per section 2 of the Trade Unions Act, 1926, "The appropriate Government means, in relation to Trade Unions whose object are not confined to one state, the Central government, and in relation to other Trade Unions, the State Government".*

(b). *As per Gazette Notification (SO 318, dated 23<sup>rd</sup> January, 1962) issued by Ministry of Home Affairs, the powers and functions of the Central Government have already been delegated to the Chief Commissioner S.O. No. 2709, dated 07.09.1966) under the Indian Union Act, 1926.*

Ministry of Labour & Employment has also forwarded copy of notification dated 23.01.1962. The copy of letter dated 07.07.2023 and notification dated 23.01.1962 are enclosed for reference.

You are directed to take appropriate action in respect of registration of Trade Union/Federation of Trade Union having all India Jurisdiction by Registrar Trade Union Delhi, in the light of clarification of Ministry of Labour & Employment.

अधोहस्ताक्षरी को उपरोक्त विषय पर श्रम और रोजगार मंत्रालय के कार्यालय ज्ञापन एस-13011/01/2023-आईआर (पीएल) दिनांक 18.04.2023 का उल्लेख करने तथा ट्रेड यूनियन अधिनियम, 1926 के तहत केंद्र सरकार की शक्तियों के प्रत्यायोजन के संबंध में निम्नलिखित अधिसूचनाओं की प्रतियां अग्रेषित करने का निदेश हुआ है:-

- (i) ट्रेड यूनियन अधिनियम, 1926 के अधीन, उप राज्यपाल, हिमाचल प्रदेश, मुख्य आयुक्त, दिल्ली, मणिपुर, त्रिपुरा और अंडमान एवं निकोबार द्वीप समूह को "केंद्र सरकार" की शक्तियों के प्रत्यायोजन के संबंध में दिनांक 23.01.1962 की अधिसूचना।
- (ii) ट्रेड यूनियन अधिनियम, 1926 के तहत प्रशासक, गोवा, दमन और दीव को "केंद्र सरकार" की शक्तियों के प्रत्यायोजन के संबंध में दिनांक 27.08.1963 की अधिसूचना।
- (iii) ट्रेड यूनियन अधिनियम, 1926 के अंतर्गत प्रशासक, पांडिचेरी को "केंद्र सरकार" की शक्तियों के प्रत्यायोजन के संबंध में दिनांक 28.09.1963 की अधिसूचना।

So 318. - In pursuance of clause (1) of article 239 of the Constitution and in partial modification of the notifications of the Government of India in the late Home Department No. F. 216/37-Public dated the 1st April, 1937 and in the late Ministry of State No. 104-J (S.R.O. 460) dated the 24<sup>th</sup> August, 1950 in so far as they relate to the exercise of powers, and the discharge of functions, under the Indian Trade Unions Act, 1926 (16 of 1926) by the Administration of Union territories, and also in supersession of the notifications of the Government of India in the late Department of Labour No. L. 3006 dated the 8<sup>th</sup> August, 1941 and in the late Ministry of Labour No. L.R. 26(29) dated the 24<sup>th</sup> February, 1948, the President hereby directs that the Lieutenant Governor of Himachal Pradesh and the Chief Commissioners of Delhi, Manipal, Tripura and the Andaman and Nicobar Islands, shall, subject to the control of the President and until further orders, exercise the powers and discharge the functions, of the Central Government under the Indian Trade Unions Act, 1926 (16 of 1926) within their respective territories.

So. 319. - In pursuance of clause (1) of article 239 of the Constitution, the President hereby directs that the powers of the State Government and sub-section (1) of section 4 of the Criminal Law Amendment Act, 1961 (23 of 1961) shall, subject to the control of the President and until further orders, be exercised by the Lieutenant Governor or the Chief Commissioners, as the case may be, of the Union territories of Delhi, Himachal Pradesh, Manipal, Tripura and Andaman and Nicobar Islands, within his jurisdiction.
