(a). As per section 2 of the Trade Unions Act, 1926, "The appropriate Government means, in relation to Trade Unions whose object are not confined to one state, the Central government, and in relation to other Trade Unions, the State Government".

(b). As per Gazette Notification (SO 318, dated 23<sup>rd</sup> January, 1962) issued by Ministry of Home Affairs, the powers and functions of the Central Government have already been delegated to the Chief Commissioner S.O. No. 2709, dated 07.09.1966) under the Indian Union Act, 1926.

Ministry of Labour & Employment has also forwarded copy of notification dated 23.01.1962. The copy of letter dated 07.07.2023 and notification dated 23.01.1962 are enclosed for reference.

You are directed to take appropriate action in respect of registration of Trade Union/Federation of Trade Union having all India Jurisdiction by Registrar Trade Union Delhi, in the light of clarification of Ministry of Labour & Employment.


