Subject: Note dated 04.01.2023 of Hon'ble Chief Minister regarding certain information


Kind reference is invited to the note dated 04.01.2023 of Hon'ble Chief Minister vide which the following information has been sought by tomorrow (i.e. 05.01.2023), after mentioning that "Barring transfer postings, include all other matters and don't assume them to fall under "services"":

- (i) List of all cases where directions were issued by Hon'ble LG directly to CS on matters related to transferred subjects;
- (ii) All those cases where reports were directly submitted by CS to Hon'ble LG on matters related to transferred subjects;
- (iii) List of such cases wherein CS has obtained comments of respective Ministers on some issues and then sent file directly to Hon'ble LG without routing it through Minister and the CM.

2. In this regard, it is informed that a copy of the said note dated 04.01.2023 was handed over by Hon'ble CM to the undersigned during a meeting scheduled at 04:00 p.m. on 04.01.2023 (the said meeting was ended around 05:00 / 05:15 pm). Further, the undersigned was attending the Second National Conference of the Chief Secretaries scheduled from 05.01.2023 (A/N) to 07.01.2023 (A/N) and during this period the charge of Chief Secretary was looked after by Additional Chief Secretary (GAD).

3. It is also informed that so far more than 4,700 files have been processed by the O/o the undersigned as per e-Office reports and more than thirty thousands of receipts have also been processed since the undersigned took over charge as Chief Secretary on 21.04.2022.

4. To provide information as sought by Hon'ble Chief Minister, such sizeable number of records are to be checked to ensure that verified information be provided to Hon'ble Chief Minister as sought vide note dated 04.01.2023. Therefore, compilation of information may take some time and will be provided to the Hon'ble Chief Minister at the earliest.
