OFFICE ORDER

A meeting of Departmental Promotion Committee to consider the regular promotion of Fireman to the post of Leading Fireman in the pay scale of Rs.5200-20200/- plus grade Pay of Rs.2400/- (Pre-Revised) was held on 11.02.2019 and considered the suitability of Sh. Rajender Singh, L.F.M-10/53 (D.O.B-24.09.1965) Snty.816 has been promoted vide order No. F.2(308)/DFS/HQ/Prom/L.F/2019/3050 dated 19/02/2019.

Further order that Sh. Satish Kumar, L.F.M-4/53 may exercise his option with regard to the fixation of pay if any as per FR-22(1)(a)(1) within one month from the date of issue of this order.
