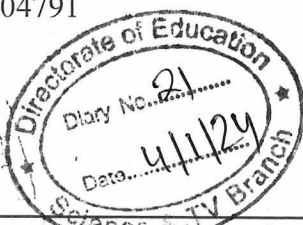

**Tentative Programme**

The objective of this awareness program is to promote a better understanding of LiFE's aspirations and the value of a sustainable lifestyle in changing environments.

Various activities will be conducted in which school students from different schools in Delhi will participate. A detailed list is mentioned below:

**Day-1**

- **Exhibition stall-** An exhibition stall will be set up at India Gate in which Delhi based EIACP PC RPs and other EIACP PC RPs across India would be invited to display a gist of the activities carried out by each centre. The centres would also display the eco-friendly products prepared by GSDP candidates under various courses.
- **Setting up of selfie booth-** Selfie booths will be set up at different locations at India Gate, where students and public would be taking photographs along with the selfie booths.
- **Nukkad Nattak-** Cultural clubs from various colleges of Delhi University and other universities will be invited to perform Nukkad natak on various themes highlighting Mission LiFE.
- **Eco-Fashion show-** A fashion show will be organized for school students, in which schools will be mentioned to select students based on their creativity in designing dresses using eco-friendly materials. First three winners will be felicitated with prizes. Registration will be completed prior to the event.
- **Cultural events-** Schools will be invited to perform group dance/group songs focusing on earth/conservation of environment. First three winners will be felicitated with prizes. Registration will be completed prior to the event.
- **Bicycle rally-** Bicycle rally will be organized in inner circle of India Gate to promote the adoption of sustainable lifestyle. First three winners will be felicitated with prizes. On-spot registration will be adopted for this activity.

**Proposed Date-** 09<sup>th</sup> February, 2024 (7:30 am onwards)

**Day-2**

- **On spot face painting competition-** The face painting competition will be held focusing on 7 themes of Mission LiFE.
- **Poster making competition-** The competition will be held for school students focusing on seven themes of Mission LiFE.
- **Demonstration on Waste segregation and composting:** Waste segregation and composting will be demonstrated for school students, college students and general public.
- **Photography/painting exhibition:** Wildlife photographers and other artists will be invited to display the paintings/photographs focusing the themes related to nature conservation/themes of LiFE. First three winners will be felicitated with prizes. Registration will be completed prior to the event.
- **Diya decorating competition:** Competition will be held for school students since Diwali falls in the month of November. Diyas will be provided to the participants and Registration will be completed prior to the event. First three winners will be felicitated with prizes.

**Proposed Date-** 10<sup>th</sup> February, 2024 (7:30 am onwards)

Besides these activities, there will be screening of the Mission LiFE documentary and the Mission LiFE pledge will be taken by the participants and the public gathering.

The event would be organized to raise mass awareness about the sustainable lifestyle practices and its impacts on the Environment, to engage young school and college students and socially responsible citizens from NGOs, RWAs in an inclusive manner to support LIFE for environmental practices, to increase the visibility of EIACP Activities in Delhi and it would also give students a common platform to participate in live interactions and know more about the Environment, sustainability, green lifestyle, waste management, clean energy etc.
