**CIRCULAR**

**Sub: - Regarding Issuance/Generation of Posting Orders through MIS for Relieving/Joining on the Promotional Post of PGT (As Applicable) in respect of All TGTs (For Different Subjects) Promoted from the Govt. Schools of District North.**

In pursuance of promotion order No. F.NO.DE.2(2)/(3)/Promotion/2022/E-II/1914 dated 08.12.2023 and vide order No. F.NO.DE.2(2)/(3)/Promotion/2022/E-II/1915 dated- 08.12.2023, and further posting order dated 29.12.2023 the district level Screening Committee was constituted by DDE District North, for checking/Verification of original documents of 24 promoted teachers (from the Govt. Schools of District North) from the post of TGT/TGT(MIL) to PGT/PGT(MIL) as per existing RRs.

In this regard, a schedule for document verification of promoted TGTs was conveyed vide circular no. F.No.DDE/N/Admn./2024/3788-3795 dated- 05.01.2024.

Accordingly, document verification of all the 24 TGTs who promoted to the post of PGT/Lecturer was carried out on 09.01.2024. Out of 24 candidates 23 candidates reported for verification of their original documents and all of them are found eligible for promotion to their respective post of PGT/Lecturer.

Further, the posting orders in respect of following TGTs were issued/generated through MIS as available at District Level for further joining on their respective promotional post after relieving from their respective parent school accordingly:

Documents have been verified by the District Screening Committee on the basis of the original documents produced by the teachers concerned at the time of the document verification on 09.01.2024.

The promotion will be subject to the following conditions:-

- (i) The promotion is further subject to vigilance clearance in terms of DoP&T OM No.22011/4/91-Estt.(A) dated 14.09.1992, OM No. 22012/1/99-Estt.(D) dated 25.10.2004 & OM No.22034/4/2012-Estt.(D) dated 02.11.2012. In case of pendency of such proceeding, the matter may be reported to E-II Branch, Directorate of Education immediately.
- (ii) The promotion is subject to the condition that the teacher fulfils all the requirements as laid down in the RRs of PGT/PGT (MIL) post of this Directorate.
- (iii) The promotion is effective from the date of assumption of charge of the post of PGT/PGT (MIL) post of this Directorate.
- (iv) The promotion shall remain subject to outcome of further orders that may be passed by the Hon'ble Supreme Court in the case of Jarnail Singh & Ors. (Civil Appeal No. 629 of 2022) arising out of SLP (C) No. 30621/2011) as conveyed by the DOPT vide O.M No.36012/16/2019-Estt. (Res.) dated 12.04.2022 duly endorsed by services department vide letter no. F.19(17)/2018/S.IV/631-638 dated 05.05.2022.

Therefore, after joining of the teacher, the HOS concerned of the respective schools, where these teachers have to join on their respective promotional posts of PGT/Lecturer, are hereby advised to get their documents verified from their universities to ensure authenticity/genuinity of the documents.

All concerned HOS are hereby informed to take further necessary action at their end and ensure that the concerned promoted teachers are relieved from the post of TGT and joined on the promoted post of PGT accordingly.
