SamagraShiksha-Delhi is entrusted with the responsibility of ensuring timely and accurate online Data Entry in Unified District Information System of Education (UDISE+) as directed by the Ministry of Education, Govt. of India.

Therefore, all Head of Schools of all managements (DoE, DOE Aided, DoE Un- Aided, MCD, MCD Aided, MCD Un-Aided, DCB, DCB Unaided, NDMC, NDMC Aided, NDMC Un-Aided, JamiaMiliaIslamia, KVS, JNV) are hereby directed to check/ensure that the accuracy of data is maintained while filling online UDISE Plus data of Children with Special Needs on web portal [www.udiseplus.gov.in](http://www.udiseplus.gov.in).

Further, all DPOs/DDEs are directed to ensure that DDE Zones, DURCCS, CRCCS, District Coordinators (IE) including himself/herself have checked/authenticated the correctness of the online UDISE plus data.

Further, concerned HoS shall ensure that the information of Children with suspected disabilities that have been screened through tools of Prashast app, shall be filled in UDISE data of 2023-24 by mentioning 40% disability and ensure issuance of disability certificate/UDID for the said suspected children.

Non compliance in this regard shall be viewed seriously as the data shall be sent to MoE (GoI) in a further course of time.
