CIRCULAR

Subject: Guidelines for the admissions for class 9 in the Delhi Model Virtual School (DMVS) for the academic year 2024-25.

The Government of NCT of Delhi has established the Delhi Model Virtual School which is a full time regular school in virtual mode. The school operates with the principle of 'Anywhere Living, Anytime Learning, Anytime Testing' and is governed by the 'Delhi Schools of Specialized Excellence'. The school is affiliated to the Delhi Board of School Education (DBSE).

Delhi Model Virtual School provides high-quality education in an online setup. The brief details about the salient features of the school, eligibility criteria, and admission process to be followed are stated below.

Salient Features of the Delhi Model Virtual School:

1. DMVS aims to provide flexibility on multiple dimensions with the spirit of increasing access and inclusion
 - Flexible schooling opportunity,
 - Diverse options of foundational and career-oriented skill courses,
 - Personalized and self-paced learning,
 - Support for competitive exams preparation,
2. It ensures seamless learning experience through live classes, recorded sessions, assignments and assessments, curated videos, tutorials, and personalized mentoring sessions.
3. For the academic year 2024-25, DMVS will be functional in the morning shift. The provision of evening shift is dependent on demand by applicants and subject to logistics.
4. The preferred mode for the term-end examinations will be online. However, these may be conducted in-person at a physical centre in Delhi as per the policies of DBSE.

The operational guidelines for the admission process and other details are as follows:


1. For the academic year 2024-25, the admissions are open for Class 9.
2. The online registration for Class 9th is open from **12th March 2024** till **31st March 2024** on the website link: www.dmvs.ac.in
3. The eligibility criteria for the students is as follows:

- Students who have passed class 8 from any recognized or government school in last 2 years (with valid identity and residence proof) are eligible to apply
 - Age Limit: 13-18 years *as on 31st March 2024*
4. The admission process for Class 9 is a three-step procedure, as follows:
- **First Step-** Online Application Form
 - **Second Step-** Online proctored/offline Entrance Exam, depending on the number of applications
 - **Third Step-** Admission confirmation & document verification

Note: Selected students may have to provide a local address of Delhi at the time of document verification.

5. Delhi Model Virtual School will organize an online webinar series and counseling sessions to provide detailed information about the school and admissions process. All the interested applicants and their parents/guardians may attend the same.
6. Reservation to SC, ST, OBC (Non-creamy layer) and Divyang children as per DoE norms.
7. Qualifying cut off score for the entrance exam will be fixed by the concerned academic authority.
